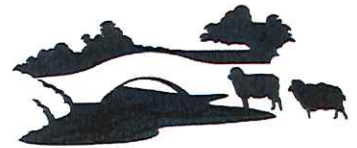

It was noted that, with one councillor absent, and one position vacant, further allocation of special responsibilities was best deferred to a later Meeting.

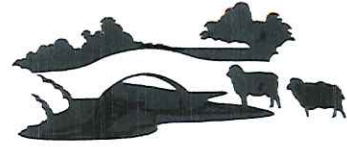
There being no further business the Chairman declared the meeting closed at 18:50.






